Butternut Road was paved without funding or authorization in Highway Working Agreement.

- 6. Camera System Update/Replace for Town Hall Bruce Giuda made the motion to accept quote DTIQ3953 from Directive for payment up to \$23,869.00 Keith Lilley seconded the motion all agree motion carried. Town Justice has applied for JCAP grant for this project.
