Privilege of the Floor: Allen Ruffles spoke concerning the County collecting property taxes. James Powers stated he will be running for County Representative on the November Ballot. Bruce Giuda stated that Town Council Members will be addressed as Council Members, a New York State Law, not Councilman.

inch minus Crusher Run @ \$9.00 per yard and Burrell's Excavating, Inc bid for 3500 yards Crushing 1 inch minus Crusher Run @ \$9.00 per yard. The non-collusion form and the Iranian Divestment form were completed properly. Keith Lilley seconded the motion all agree motion carried.

- 3. Keith Lilley made the motion to allow Supervisor Bruce Giuda to sign the NYSEG Easement for new Utility Poles at the Copes Corners Park, John Hill seconded the motion all agree motion carried.
- 4. Keith Lilley made the motion to approve Payments of vouchers 25101 25141 for \$344,215.62 Teresa Winchester seconded the motion all agree motion carried.

Board Discussion: Jason Fleming from Depot Engineering will work with Bruce Giuda on applying for a Million Dollar NY State Grant for the Copes Corners Park.

The suggestion was made that the culverts (12) used on Taylor Road be charged to Chips.
